NOTE:

- -Selling directly, the company will only charge new owner a registration fee of 5% of the current market value of the property, and the new owner makes a payment for the documentation (Deed and Survey).
- -For engaging the service of the company for Resale:
- I. The company will look for a suitable buyer to purchase the said plot of land at the current market value within 90 days.
- ii. The company will deduct 25% agency and transactional fee, the balance of proceed of the sale will be paid to the client (seller).
- iii. Upon every refund of payment, the company shall deduct 30% administrative fee.

11. IS THERE ANY RESTRICTION AS TO THE TYPE OF BUILDING I CAN ERECT ON THE LAND?
